"AMENDMENTS to the DECLARATION of COVENANTS, CONDITIONS, AND RESTRICTIONS of SPRING GARDENS - January 1, 2001

"In accordance with paragraph X-C paragraph IV-C, Establishment of Annual Assessment is amended to read:

- "2. The Board of Directors shall also set a date for a Special Meeting of the membership, to take place during October and shall deliver to each member of the Association a notice of the meeting. At the October Special Meeting the Board of Directors shall explain the proposed budget to the membership. Each item of the budget shall be discussed and the members shall be given the opportunity to ask questions or request further explanation of such items.
- "3. On or before December 1, the membership may request by petition signed by sixtyfive percent (65%) of the members entitled to vote, a Special meeting of the membership to reconsider the proposed budget. Upon receipt of such request, the Board of Directors shall schedule such meeting and the purpose thereof. If a petition, signed by sixty-five percent (65%) of the members entitled to vote, is not received by the Board of Directors the proposed budget shall be considered approved as of December 2."

"Paragraph X-C Amendment is replaced and amended to read:

"C. Amendment This declaration of Covenants and Restrictions may be amended by an instrument signed by not less than fifty-one percent (51%) of the owners. Any amendment must be recorded."

"Jack Sammelmann made a motion to adopt the foregoing amendments. Motion seconded by Vince Nangle and unanimously approved."
